# Overview of Latest Rural Developments 8-14 September 2011

## WTO and Neighbourhood Policy

Ukrainian President Viktor Yanukovych has met with former Polish President and Special Representative of the Polish Presidency of the European Union Aleksander Kwasniewski. Yanukovych noted the special importance of an active dialogue with Poland during its presidency of the EU. Kwasniewski, in turn, confirmed close relations between the Polish presidency of the EU and Ukraine and the constant attention to what is happening in the country.

Yanukovych and Kwasniewski expressed hope for the forthcoming communication at the 8th Yalta Annual Meeting "Ukraine and the world: common challenges, common future," which will be held on September 15-18 at the Livadia Palace in Crimea, where current problems will be discussed in more detail.

Memorandum on bilateral cooperation programme in agriculture was signed between the Ukrainian Ministry of Agrarian Policy and Food and the Swiss State Secretariat for Economic Affairs.

The memorandum was signed by the First Deputy Minister of Agrarian Policy and Food Mykola Bezugly and the Swiss Ambassador to the WTO, the Representative of the Federal Council for Trade Agreements Lutsius Wasescha.

Ukraine intends to renegotiate the terms of its membership in the WTO this year. This is stated in the letter from the Prime Minister Mykola Azarov to the Head of the Ukrainian Union of Industrialists and Entrepreneurs, MP Anatoliy Kinakh. The letter notes that by the end of the year the Government plans to initiate talks about changing tariff commitments which Ukraine took when joining the WTO. The letter was written as a response to the appeal Mr. Kinakh made that Ukraine should use its renegotiation right in accordance with Art. XXVIII of the General Agreement on Tariffs and Trade (GATT). According to this article, the WTO members have the right to renegotiate customs duties every three years. The next three-year period is to be started from 2012. The experts recommend the Cabinet to prepare itself to match with other WTO members` requirements which are quite rigid. It should be noted that instead of 4 months the Government has only few weeks to submit the application. The application for starting the procedure of negotiations must be submitted within the period from 6 to 3 months before the end of three-year period, and, in addition, the rules of trade diplomacy involve prior consultation with major trading partners.

September 12, The National Institute for Strategic Studies under the President of Ukraine held the third meeting of the Working Group entitled the Regional Dimension of the European

Integration Strategy for Ukraine: Regional Development and Interregional Cooperation in the Framework of The National Convent of Ukraine on the EU. The meeting was held in partnership with the Slovak Foreign Policy Association Research Centre and with the support of the Slovak Development Fund (Slovak Aid). The topic of the meeting was "The Central region: inter-regional cooperation as a platform for cooperation between the regions of the EU".

The meeting resulted in policy recommendations aimed at stimulating and supporting the participation of Ukrainian regions in interregional cooperation projects.

The EU Commissioner for Enlargement and European Neighbourhood Policy Stefan Fuele will visit Ukraine on September 15-17 to attend the 8th Yalta Annual Meeting "Ukraine and the World: Common Challenges, Common Future".

According to the Ukrainian foreign ministry spokesman Olexander Dikusarov, Mr. Fuele plans to meet with Ukrainian officials, including Foreign Minister Gryshchenko. The parties will discuss the issues related to the conclusion of Association Agreement, creation of free trade area, and development of the visa-free dialogue.

In Vinnytsia oblast the veterinary police officers revealed illegal food production facilities in a canteen cellar. 248 kg of meat products of dubious quality were removed from circulation. In Kiev the veterinary police officers suspended the operations of 8 kiosks which were

manufacturing and selling meat dishes without proper permits and under unhygienic conditions. The meat processing equipment and 104 kg of low quality animal products were seized.

## Market infrastructure

The Pioneer Hi-Bred company, which is part of the DuPont Corporation, is investing \$ 10 million into the construction of a seed storage centre in the village of Stasy, Poltava oblast. The construction is planned to be completed by the beginning of 2012 sales season. Some 4,000 sq m will be destined for storing seeds, with half of the area equipped with air-conditioning. Fifteen full-time workers will manage the centre.

During the first 7 months of 2011 the growth in livestock production amounted to almost 3%, compared to the same period last year, the Minister of Agrarian Policy and Food Mykola Prysyazhnyuk said at a press conference entitled "The Agricultural Sector Outcomes during the first seven months in 2011." The production growth in the livestock sector is 2.8% due to the qualitative structural changes introduced by the Government. The agri enterprises increased their volume of livestock and poultry production by 6.4%, of pig production by 11%, and of poultry production by 6.8%.

According to the APK-Inform: Vegetables and Fruits project experts, professional potato producers have serious difficulties with selling their products at reasonable prices in Ukraine, since small-scale farmers agree to sell potato at prices considerably below its cost. The intermediaries are now buying potatoes from small-scale farmers for 0.7-0.9 UAH/kg to resell it in winter and spring. In the western regions the wholesale prices have already decreased to 1.2-1.4 UAH/kg due to excess of supply. It was 3.5 years ago that such a low price was observed for the last time, but the cost of growing potato then, however, was about 2 times lower. "The cost of growing late varieties of potato on specialized farms will in 2011 be from 1.5 to 2.0 UAH/kg. The cost of growing potato on small-scale farms is not being estimated, but in most cases it is even higher than that," the APK-Inform: Vegetables and Fruits project director Tatyana Getman said.
