WTO and Neighbourhood Policy

The Polish President Bronislaw Komorowski congratulated the Ukrainian President Viktor Yanukovich upon the success Ukraine made in integrating into the EU. This he said at a press briefing after meeting with Viktor Yanukovych who visited Warsaw to participate in the Eastern Partnership Summit. The Polish President called the Eastern Partnership Summit a good opportunity for analyzing Ukraine's progress in European integration. "The almost agreed-upon FTA agreement testifies to achievements upon which I would like to congratulate Ukraine. This is a very important step in the right direction", he said, and noted that Ukraine and Poland still have to work on the Association Agreement, and not to forget about the need to ratify these documents.

In his turn, Mr. Yanukovych thanked Mr. Komorowski for the high level at which the Eastern Partnership Summit was carried out. According to him, perfect organization and involvement of high-rank representatives make it possible to discuss all matters concerning Ukraine's relations with Poland and the EU in a traditionally friendly atmosphere.

Ukraine's President Viktor Yanukovych believes that now is the time to implement specific actions in order to provide practical content to the Eastern Partnership Initiative. This he said in Warsaw at the plenary session of the Eastern Partnership Summit. According to Mr. Yanukovych, the Eastern Partnership Initiative has become an important auxiliary tool for the EU partner countries to develop their relations with the Union and promote their European aspirations. It must be a far-reaching project contributing to the obliteration of obstacles to countries interested in integrating into the European Union and willing to fulfil their respective obligations.

"I am confident that giving Ukraine and other partner countries that have achieved progress in the EU integration process a clear political signal about their European perspective, and materialising the Eastern Partnership Initiative by elaborating specific projects will be a key to the Initiative's success and a powerful impetus for continuation of internal reforms in these countries", Mr. Yanukovych said.

Market infrastructure

The Dragon Capital senior expert Tamara Lovchenko believes that most companies will continue to lease the land from landowners under long-term contracts after the land market is launched in Ukraine. "The representatives of most companies say that they are not going to buy land, and will continue to lease it under 10-15 years contracts", she said. Ms. Lovchenko said the rent will rise by half. "The rent will increase to \$100 per 1 ha," she said, adding that some companies are currently paying \$60-70 per 1 ha of good quality land.

The agricultural land should not presently be sold to foreigners, the First Deputy Minister of Agrarian Policy and Food Mykola Bezugly said at a press conference. According to him, this point of view can be "very simply" explained."Even if we reassess the land prices so, that 1 hectare will in average cost UAH 19.9 thousand. Provided there are some 28 million hectares of arable land in Ukraine, the price of all lands will equal to UAH 560 billion (55 billion euro). Although it is a huge amount for our country, it is negligible in terms of the EU budget or its Stabilization Fund, which totals 2 trillion Euro. We must realize what the consequences could be if someone would come and buy half of the Ukrainian arable lands for money additionally emitted in North America or Europe", Mr. Bezugly said.

The agricultural producers will, in total, lose UAH 10 billion if export duties for grain will be extended and those for oilseed and sunflower oil introduced in 2012, the Director General of the Ukrainian Agrarian Business Club Volodymyr Lapa said. "In 2012 the direct loss of agricultural

production will exceed UAH 8 billion. The published draft law will also result in significant indirect losses with the total amount of losses equalling to over UAH 10 billion. It is the largest fiscal pressure the agricultural sector experiences since the introduction of preferential taxation in late 90s", he said.

As of October 1, 2011 the land shares owners concluded 4.6 million contracts leasing out 17.3 million hectares of land for UAH 5.9 billion, the State Agency of Land Resources reports. The average rent per year is UAH 338.5 per 1 ha with in-kind payment prevailing in 65.5% of cases. The sum of money actually paid to land shares owners amounted to UAH 3.4 billion, accounting for 57.7% of the total amount contracted.

The Minister of Agrarian Policy and Food Mykola Prysyazhnyuk met with farmers and agricultural producers from all regions of Ukraine to hear all their complaints and suggestions and voice his own clear position concerning the export restrictions. "Our ministry is not able to influence the Ministry of Finance, so we should work together to convey the fact that export duty is a big minus for farmers to the Government", he said, and added that the Ministry has introduced to the Parliament a draft law abolishing export duties. "My vision and suggestion is that we should also introduce a draft law refunding VAT directly to grain producers", Mr. Prysyazhnyuk said. Following the meeting, the Memorandum of Understanding between the MAPF, the Agrarian Union and the Farmers Association in Matters of Tax Policy and Agricultural Exports was elaborated.
